**Camper Rules & Regulations**

**FINE ARTS CAMPS EUROPE**

CHTM o.p.s. management has developed policies in order to maintain safety, order and a pleasant environment for all participants of the Fine Arts Camps Europe (FACE). Counselors must explain the rules to campers so that they understand their purpose and realize consequences for breaking them.

**Vandalism, Theft**

Vandalism, destruction or defacement of camp property, and graffiti will not be permitted. Campers will protect and respect the property of other students, employees, facility owner, and the C.M.C.Y. non-profit organization.

**Fire, Dangerous Materials**

Since the camp facilities are situated in the forest, only authorized staff members may manipulate with fire and other dangerous materials.

**Out of Bounds**

Unless accompanied by an authorized faculty or staff member, campers are required to stay within the boundaries of the campus set by the camp management.

**Uniform**

Campers, teachers and staff wear uniform for all concerts and some other activities as decided by camp management. **Campers are required to wear their name tags all the time.**

**Attendance**

All students are required to participate in scheduled classes, rehearsals, concerts and activities unless excused by the Health Director, Staff Director or Camp Director.

**Clean-up**

It is necessary to maintain the whole camp area clean. The Staff Director will coordinate clean-up of camp facilities. Campers are responsible for keeping their area clean. Cabins and rooms will be inspected by the Health Director.

**Public Displays of Affection**

All campers will make friends at camp, many with the opposite gender. However, for the sake of the general population at the camp and our guests from off-camp, we must request that physical affection be limited to proper place and time. Campers are expected to have the maturity, judgement, and self-control.

**Temporary Departure from Camp**

Campers under 18 are permitted to leave camp temporarily only with a parent / guardian or authorized staff member. Campers are permitted to go with other adults providing the parent / guardian sent written permission in advance. Each participant of the camp regardless of age must notify the Camp / Staff / Program Director prior his/her departure from the camp.

**Camper Pledge**

As a camper of the Fine Arts Camps Europe I agree to follow Camp Regulations and cooperate with conductors, teachers and staff. I agree not to use or possess tobacco, alcoholic beverages or illegal drugs and not to go out of bounds without permission. I understand that violation of these rules may result in my dismissal from the program.
